AGREEMENT NOT TO BRING, JOIN OR PARTICIPATE IN CLASS ACTION: To the extent permitted by law, you agree that you will not bring, join or participate in any class action as to any claim, dispute or controversy you may have against us, our employees, officers, directors, services and assigns. You agree to the entry of injunctive relief to stop such a lawsuit or to remove you as a participant in the suit. You agree to pay the attorney's fees and court costs we incur in seeking such relief. This agreement does not contribute a waiver of any of your rights and remedies to pursue a claim individually and not as a class action in binding arbitration as provided above.
